Participant represents and warrants that: (i) Participant has obtained all necessary right, license and privilege to authorize Mr. Olympia to use the Music in connection with the Event and/or Broadcast; (ii) Mr. Olympia shall not be required to pay any royalties, fees, commissions, costs, expenses or other charges of any kind (including but not limited to any music or performing rights societies such as ASCAP, BMI and SESAC) in order to use the Music in connection with the Event and/or Broadcast; (iii) the Music shall not violate, infringe or misappropriate any copyright, trademark or other proprietary or personal right of any third party; (iv) the Music shall not contain any matter that is obscene, libelous, violative of any third party's right of privacy or publicity or otherwise in contravention of the law or the rights of any person or entity; (v) there are no agreements or understandings, written or oral, that would limit, restrict or conflict with Mr. Olympia's right to use the Music in connection with the Event and/or Broadcast; (vi) Participant is not a minor; and (vii) all of the foregoing representations and warranties are true and correct on the date hereof and shall be true and correct at all times during and after the Event and/or Broadcast.

Participant shall forever indemnify, defend and hold Mr. Olympia and its affiliates, and each of their respective successors, assigns, officers, directors, agents and employees harmless from and against any and all losses, liabilities, claims, costs, damages and expenses (including but not limited to reasonable attorney fees) arising from or in connection with any allegation that: (i) any of the representations and warranties made by Participant herein are false, misleading or incorrect at any time; (ii) the Music violates, infringes or misappropriates any copyright, trademark or other proprietary or personal right of any third party; and (iii) the Music contains matter that is obscene, libelous, violative of any third party's right of privacy or publicity or otherwise in contravention of the law or the rights of any person or entity.

Participant shall not make or institute a lawsuit or claim liability, in law or in equity, against Mr. Olympia, or any of its assignees, licensees or successors (including any agency, client, broadcaster, periodical or other publication) based upon any matter related in any way to the Music, Broadcast and/or Event.

This Agreement shall be governed by and construed in accordance with the laws of the State of Florida, without regard to conflict of law principles. Participant specifically agrees that any controversy arising under this Agreement shall be adjudicated before a state or federal court of competent jurisdiction located in Palm Beach County, Florida.
